

2020 Dues Schedule and OFAH Membership

As approved by General Membership, Fall 2016

If a new member is applying for membership in any month other than December the new member is entitled to a reduced rate based on the number of months remaining in the year.

The \$100.00 Single / \$140.00 Family per year membership fee with our 13% GST/HST taxes added is apportioned at a declining rate per month. OFAH dues remain constant throughout the year.

Example: A person applying for membership in April should submit \$76.00 since their membership will not become active until the General Meeting on the last Wednesday of April. They would hold a valid membership for May thru December at which time they will be required to submit the full membership fee of \$113.00

Reminder: There are no initiation fees, permit costs, or work hours associated with membership in the Rondeau Rod and Gun Club.

Memberships expire on December 31st. A fee of \$20 will be charged to any member after the January General Meeting. After February General Meeting members must re-apply for membership (requires acceptance) paying any late penalty as well.

Members with handgun ATT's are reminded that their permits may no longer be valid if their membership lapses. The Chief Firearms Office is no longer notified of any persons with memberships that have lapsed. The legal obligation is on the part of the gun owner themselves to maintain a membership in good standing at an Ontario approved firing range. Failure to comply with the Federal and Provincial regulations may place the firearms owners at risk of charges under the Canadian Criminal Code.
